## INDIGO AT SIX CLUB GUIDE

### CLUB

In the evening, please leave the club punctually before the official closing time. We kindly ask you to comply with the club rules and to follow the instructions of our staff. Please wear your street shoes only on your way to the lockers room. We kindly ask you not to use any mobile phones in the fitness room. Please refrain from smoking.

### CHECK-IN

On every visit you have to check-in at our reception by using your own INDIGO member card.

### BEVERAGE

Please use only closable beverages in the club.

### CLOTHING

The fitness areas may only be used in appropriate and fresh sportswear. This includes, in particular, suitable and clean sports shoes that have not been used for outdoor activities. By changing shoes and clothes in the changing room you support our efforts in the cleanliness.

### FITNESS ROOM

The use of a sweat absorbing towel is mandatory. Please return the dumbbells, weight plates, bars and other equipment to their place. Please leave the training equipment in between your training sets if you are working out with multiple training sets.

### LOCKERS

The lockers are for use during training only. Please lock them with your personal combination padlock and empty them after each visit. We reserve the right to open the lockers with prior written notice. The stored items will be kept in the club or in a safe place (security centre via Porte B).

### LOST ITEMS

We keep lost items for up to 1 month.

### LIABILITY

You use the facilities of INDIGO at your own risk. We recommend you undergo sports medical examination before you start with your training at INDIGO. Training under the influence of drugs of any kind or alcohol is dangerous. If necessary, we can refuse admission to INDIGO to visitors who have consumed alcohol or drugs and we can require them to leave.

## GENERAL TERMS AND CONDITIONS FOR INDIGO AT SIX

1. The minimum age for members and guests is 16 years.
2. The yearly membership includes: Use of fitness machines, lockers room, showers, one large shower towel and one small training towel per visit, free water from the water stations, up to four training checks with our fitness trainers per year, one body analysis, one personal member card and one personal combination padlock.
3. The INDIGO member card allows access and use of the INDIGO AT SIX facilities. The self-check-in with the member card at the reception of the club is obligatory. A check-out is not necessary. The INDIGO member card is strictly personal, is non-transferable and cannot be altered in any way.
4. The contract period for the yearly membership is generally 12 months, but is linked to a valid work contract with SIX (internal employee) or to the work contract of an authorised contractual partner (external employee). If the work contract is terminated, the membership is also terminated. The right to use the INDIGO facilities ends on the same day the right to access the SIX facilities ends. In consultation with SIX, only internal employees are authorized to pro rata refund of the membership fee. In case the work contract is terminated by SIX, the membership fee is paid back to the member on a pro rata-basis and minus an administration fee of CHF 50.
5. The non-use of the facilities, the services or the classes does not entitle the member to a reduction or a refund of the fee.
6. The member allows INDIGO to take a picture of him/her in order to identify him/her. This picture will be strictly used only within INDIGO.
7. The members have to accept the instructions of the INDIGO staff and the Club Guide.
8. For damages following an accident, injury or illness, INDIGO denies any liability for itself or its staff members. It is the responsibility of the members and guests to be covered by an insurance. INDIGO is not responsible for the loss of any items of value, money, clothes, etc. We deny any liability for items left behind. It is the responsibility of the members and guests to be covered by an insurance.
9. INDIGO is open daily during regular opening hours with the exception of days scheduled for maintenance, cleaning, renovation and with the exception of certain holidays. The member is not entitled to a refund or an extension of his membership in the case of other closures necessary to guarantee a smooth operation of INDIGO.
10. The member acknowledges that changes to the Club Guide remain fully reserved and that they will be brought to his/her attention in due form. The member may not deduct any rights from any changes of the Club Guide. Only the current Club Guide is valid.
11. INDIGO may change its range of services and its opening hours at any time without prior notice. The member is not entitled to a refund in case of a reduction of the range of services or the opening times.
12. The rights and the obligations according to this contract can be transferred to a legal successor by INDIGO. Moving of the INDIGO facility within the boundaries of the town of Zurich does not imply the right to cancelling the contract before its normal period of expiration.
13. The contract between SIX Group Services Ltd and the member is signed digitally and online in the webshop at <https://six.indigofitness.ch>. Any modifications or termination require the written form.
14. By using the Click-to-Accept button, the member confirms that the registration form and the health questionnaire have been completed truthfully. Furthermore, the member declares that he/she has carefully read and taken note of the regulations of this contract and the currently valid Club Guide of INDIGO at SIX. The Member fully acknowledges the General Terms and Conditions and the Club Guide of INDIGO at SIX.
15. Furthermore: Employee resignation (internal or external) does not entitle to refund the membership fee. To attend group fitness classes, a INDIGO AT SIX membership is a prerequisite and is associated with an additional group fitness fee.
16. Court of jurisdiction is Zurich.
